| Following too closely (tailgating)                   | 4      |
| Inadequate Brakes                                    | 4      |
| (While driving employer's vehicle)                   | 2      |
| Failing to Yield Right-of-Way                        | 3      |
| Violation Involving Traffic Signal                   | 3      |
| Stop Sign or Yield Sign                              |        |
| Railroad Crossing Violation                          | 3      |
| Improper Passing of Lane Use                         | 3      |
| Leaving Scene of an Accident Involving               | 3      |

- Three speeding violations in 18 months still results in mandatory license revocation, regardless of points.
